It is hereby determined to be necessary and in the best interest of the inhabitants and citizens of the School District, and the School District hereby agrees, to lease and to finance the Project, in accordance with the plan of lease-purchase financing described in this Resolution.

Section 2. Pursuant to the terms of an Agreement of Lease (the "Agreement of Lease"), the School District shall provide for a lease of the real property consisting of the site on which the Project is located (the "Project Site" and together with the Project, the "Leased Facilities"), which Agreement of Lease shall run from the School District to a bank or equipment financing company (collectively, the "Bank"). The Bank shall then sublease the Leased Facilities to the School District pursuant to the terms of a Lease-Purchase Agreement or a Master Lease-Purchase Agreement (collectively, the "Lease-Purchase Agreement"). The payment schedule established pursuant to the Lease-Purchase Agreement may provide for a principal amount not to exceed \$1,400,000. The President of the Board, the Treasurer of the School District, the Superintendent of the School District, or any of them, are hereby authorized to execute and deliver the Agreement of Lease and the Lease-Purchase Agreement on behalf of the School District in accordance with the terms that said official or officials executing the same may approve. The acceptance of the Agreement of Lease and Lease-Purchase Agreement shall be conclusively evidenced by the execution of the Agreement of Lease and Lease-Purchase Agreement by any such official or officials. The Lease-Purchase Agreement shall provide for the payment of Base Rent from the School District to the Bank. Base Rent shall be payable in periodic installments over the term of the Lease-Purchase Agreement, in such amounts and at such times as shall be determined by the Treasurer, provided that the average annual Base Rent payments over the life of the Lease-Purchase Agreement shall not exceed the amount that would be required if the applicable interest rate were not to exceed four percent (4.00%) per annum applied on a maximum principal amount not to exceed \$1,400,000, such interest to be computed on the basis of a 360-day year and actual days elapsed or such other methodology requested by the Bank. The initial term of the Lease-Purchase Agreement shall be no later than June 30, 2015 provided that the School District shall have the right to renew the Lease-Purchase Agreement for a total of not more than five (5) additional one-year renewal terms as determined by the Treasurer, beginning on July 1, 2015 and continuing on July 1 of each year thereafter through and including the last renewal term. "arbitrage bonds" under Sections 103(b)(2) and 148 of the Internal Revenue Code of 1986, as amended (the "Code") and the regulations prescribed thereunder and will, to the extent possible, comply with all other applicable provisions of the Code and the regulations thereunder to retain the Federal income tax exemption for interest on said lease obligations, including any expenditure requirements, investment limitations, rebate requirements or use restrictions. The Treasurer or any other officer having responsibility with respect to the issuance of the lease obligations is authorized and directed to give an appropriate certificate on behalf of the School District, for inclusion in the transcript of proceedings, setting forth the facts, estimates and circumstances and reasonable expectations pertaining to said Section 148 and the Regulations.

<u>Section 7</u>. The lease obligations provided for under the Lease-Purchase Agreement are hereby designated a "qualified tax-exempt obligations" for the purposes set forth in Section 265(b)(3) of the Internal Revenue Code of 1986, as amended, as this Board does not reasonably expect that it will authorize more than \$10 million in tax-exempt obligations during this calendar year.

<u>Section 8</u>. It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
