School Resource Officer Agreement between Mohawk School District and the Wyandot County Sheriff's Office

(1 Year Contract effective from August 1, 2023-May 31,2024)

This agreement was made on this 8th day of June 2023 by and between the Wyandot County Sheriff's Office and the Mohawk School District, with the approval and consent of the Wyandot County Commissioners and the Mohawk School District Board.

WHEREAS, Mohawk School desires to have an active School Resource Officer (SRO) Program on school premises. Mohawk School desires that program consist of one (1) deputy, his/her vehicle, supplies and equipment for 8 hours and 30 minutes per day during the school year.

WHEREAS, Mohawk School is agreeing to pay for one hundred and eighty-four (184) school days, plus an additional ten (10) days for after hours or special details as they arise throughout the school year, if needed.

SECTION I: Payment Rate

The total compensation paid to the Wyandot County Sheriff Office by the Mohawk School District will not exceed the total of \$57,000 per calendar year, based on the hours worked at the school not to exceed one hundred and ninety-four days (194) and not to be under one hundred eighty-four days (184), at a rate of \$34.50 per hour, or \$53,958 per year.

SECTION II: Payment

The Wyandot County Sheriff's Office will send an end of school year invoice for services rendered. The Mohawk School District shall pay the amount on an annual basis, after having received that invoice, to the Sheriff of Wyandot County, to be deposited by the Treasurer of Wyandot County and credited to a special account known as the "Sheriff's Police Revolving Fund."

SECTION III: Duties

The assigned Deputy Sheriff shall perform the duties as stipulated in the Memorandum of Understanding executed between the Mohawk School District and Wyandot County Sheriff's Office.

SECTION IV: Entire Agreement

This agreement shall contain the entire agreement between the parties and no other promises, terms, or conditions shall be binding upon the parties, successor, and/or assigns.

SECTION V: Effective Date and Termination

This agreement shall bind the parties and their successors and assigns insofar as permitted by law. The term of this agreement shall commence on August 17, 2023, and terminate on May 23, 2024. Thereafter, the contract will be renewed on an annual basis by both parties beginning August 1st of each calendar year and ending on May 31st of that year.
